4. FGC Program Manager / SelectSeed CEO succession - Jack / Brian

Following a year-long process, Brian Barber, RPF has been hired to lead SelectSeed and take over FGC Program Management duties. The SelectSeed Board is very pleased to welcome Brian to the company. Mark Tamas was included and consulted in all recruitment steps. These steps will be reviewed.

5. LBIS budget update and status of "underfunded pressures" request - Brian

6. 2016/17 Business Plan document update

The 2016/17 FGC Business Plan and species plan document is complete and will be handed out. Copies will be mailed to stakeholders.

7. 2015/16 FGC Annual Report

The Annual Report is written and waiting for review and information on several items. Jack will present performance indicators achieved for last fiscal year. A final document will be ready in late October.

8. Interior seed supply and demand analysis using harvest flow information

This report was distributed as a separate document. Jack will present highlights.

This analysis uses MFLRNO harvest flow information to forecast interior seed demand. It replaces an earlier report that used licensee data. Methods and limitations will be discussed

Based on this information, the primary recommendation made is for the expansion of orchard capacity for northern lodgepole pine seed planning units (Prince George, Central Plateau, Bulkley Valley). A specific resolution regarding this will be tabled for FGC consideration.

9. Interior GRM workshops (action item from March, 2016)

Stephen and Jack developed a plan for the proposed workshops. They were to include information on breeding and orchard programs, as well as discussion on future harvest and seed needs in local areas. The plan was shelved, however, due to uncertainty with seed demand from new MFLNRO initiatives, including the Climate Action Plan, Forests for Tomorrow, the Forest Enhancement Program, and the Forest Carbon Initiative. All of these programs are expected to ramp up and will have a significant impact on seed demand. Until we have more information on these initiatives, it was felt the workshops should be delayed.

In a separate initiative, workshops on tree improvement and climate-based seed transfer are being held in 100 Mile House, Prince George, and Burns Lake on October 18, 19, and 20. These are being led by Nick Ukrainetz (MFLNRO lodgepole pine breeder) and cover part of the objective of the action item from March..

10. Review of OTIP eligibility criteria

Operational Tree Improvement Program criteria will be discussed with a recommendation to set up a subcommittee to review how these investments are made. There are two key areas for discussion:

- $1. \ Re\text{-}visit\ the\ purpose\ of\ OTIP\ and\ how\ it\ aligns\ with\ FGC\ objectives.$
- 2. Ensure that the mechanics of the call for proposals are supporting the OTIP purpose.
