Presentation on climate-based seed transfer scientific foundation -Dr. Greg O'Neill

Greg led a technical committee that developed a report outlining the scientific foundation for the development of new standards for seed transfer that will be based on climate and will allow for adjustments to accommodate new climates and anticipated future changes to climate.

5. Succession planning - Michael / Brian / Jack

The Ministry has hired Dr. Trevor Doerkson to support interior tree breeding efforts. Trevor will initially focus on the interior Douglas-fir and western larch breeding programs and work with Barry Jaquish. SelectSeed Ltd. is providing funds for this position.

Jack is getting old. We need to begin discussion of a succession plan for FGC program management services and for the management of SelectSeed Ltd. The SelectSeed Board will also be discussing this issue. Collaboration is needed.

6. FGC Annual Report for 2014/15

A report on 2014/15 performance indicators will be presented. The Annual Report document is mostly prepared.

7. FGC 2015/16 Business Plan document

This document is being printed now and will be distributed as soon as possible. Jack will provide an overview of updates on information used to develop "species plans".

8. FGC Strategic Plan for 2015-2020 and the new Pest Objective

A draft of the Strategic Plan was sent as a separate file.

An objective for the development and production of genetically pest resistant seed is new in this plan. A presentation will be made on how this objective was developed. Other parts of the Strategic Plan will be reviewed.

A formal motion to accept this plan will be requested.

9. Interior seed supply and demand analysis

This item has been discussed at previous Council meetings. Data originally collected by West Fraser Timber and Canfor on expected seed demand and supply was given to Jack to update with more recent information on expected seed supply. A report will be presented that incorporates all available information on seed supply and demand for Fdi, Pli, and Sx. The focus of this report will be identifying seed planning units (SPU) where seed supply is not expected to meet demand. These seed planning units are:

- Pli Prince George
- Pli Bulkley Valley
- Pli Central Plateau
- Sx Prince George low elevation

Other seed planning units with issues will be discussed. To meet long term FGC objectives actions on these seed supply - demand disparities is needed.

10. Improving and streamlining annual business planning, process and delivery for the FGC and TACs - Brian

Brian will lead a discussion on Council development of issues and priorities that should be given to Technical Advisory Committees prior to their development of budget requests for next fiscal year. This issue was raised at the March FGC meeting by Mark, Raoul, and Stephen.

11. BCSOA meeting funding request

The following request was received from Bevin Wigmore on behalf of the BC Seed Orchard Association:

Last year the FGC gave \$4000 towards the BCSOA biennial conference. The planning committee for the 2016 meeting is wondering if they would be able to receive similar support. The meeting will be held June 21-22, 2016 in Langley, focusing on the seed centre and the theme of cone harvest, handling and storage.
