Location information:

Skimikin Seed Orchards

From the Village of Sorrento: Proceed about 18 km east on Highway 1. Turn west on the Tappen Valley road (right after a bridge over railway tracks)

From Salmon Arm: Proceed about 17 km west on Highway 1. Turn west on the Tappen Valley road (just past an Esso Station on the right and just before a bridge over railway tracks)

- Follow Tappen Valley road about 4 km west and north (3 right angle corners)
- Turn left (west) on Skimikin Lake Road and follow it for about 4 km (curves and uphill as you approach the orchard turnoff)
- Watch for a sign on the left for Skimikin Nursery and Skimikin Seed orchards
- Turn left at the sign and follow the straight gravel road about 750 meters (go past the sign to the Skimikin Nursery driveway on the left).
- Turn 90 degrees right onto a small gravel road, through a gate, and into the Skimikin Seed Orchard site (don't follow the small gravel road the angles off to the left). You'll see trials and trees in straight rows.
- Follow the winding road for about 500m to an office building on the right.

From Trans Canada Hwy: Take exit 374 to the Yellow Head Hwy. Stay on Yellow Head Hwy for
5.1 KM Turn Left on Halston Ave. (Husky Gas Station will be on your Right) Follow Halston Ave
for 2.8 km. Turn left at sign for Northshore Business District (First Left after Overpass) This will

Agenda item 5 – OTIP subcommittee report

The committee reviewing OTIP project eligibility and process includes Annette, Tim Lee, Chris Walsh (replaced David Reid) and Jack Woods. The mandate from Council for this committee is to "proceed to stage two of the OTIP review and develop guidelines for OTIP projects that will be eligible for funding under the 2013/14 call for proposals. Draft guidelines will be reported back to Council in September, 2012". The committee did the following:

- Reviewed project eligibility as set out in last year's call for proposals and recommends changes.
- Reviewed procedures for the call, proponent preparation of proposals, reviews, and contracting and recommends changes.

A report will be presented. Following FGC discussion, the committee proposes to implement changes in the OTIP Call for Proposals document and procedures.

Agenda Item 6 – FGC Annual Report for 2011/12; FGC 2012/13 Business Plan document; Update on 2012 cone crops – Jack

Agenda item 7 – Presentation to the Mid-Term Timber Supply Review Committee – Jack / Larry / Kerry

A presentation was made on July 12 by Jack and Larry. The presentation was sent as a separate file.

The outcome of this presentation appears as a statement in the Committees report stating support for continued or increased investment in tree improvement.

Agenda item 8 – Seed Planning Unit investment ranking; Ranking of species for genecology investment – Jack

Investments in tree breeding and seed orchards are guided at a high level by priority rankings among different seed planning unit (species / seed zone / elevation band). These ranking also form a technical basis for Councils target for 75% select seed use provincially. Rankings are updated every few years and were updated recently. A presentation on the information and assumptions used will be made, as well as the outcome of the new rankings.

Investments in genecology research are ranked at a species level. The Seed Transfer TAC method for ranking species will be presented.

Agenda item 11 – Whitebark pine blister rust screening proposal – Brian / Barrie

A proposal has been submitted to the Genetic Conservation TAC to implement a long-term blister rust screening project. Proponents are Charlie Cartwright and Nick Ukrainetz from the Tree Improvement Branch and Michael Murray from the MFLNRO Kootenay Boundary Region. The proposed budget is for \$357,000 over 9 years. Field sites will remain for more than 9 years. The following are the Executive Summary and Objectives from the proposal:

Executive Summary

This proposal is for a comprehensive parent tree testing and rust resistance screening program for whitebark pine. The goal is to test 600 parent trees collected from 60 populations from throughout the range of whitebark pine in BC and the United States. Eight long-term field trials will be established to assess family level resistance to white pine blister rust. Concurrently, 35 families will be sent for rust screening and evaluation to the Dorena screening facility in Oregon. The deliverables for this project will be a set of guidelines to direct seed collections for restoration efforts including the identification of parent trees with high levels of resistance, and a set of long-term progeny tests.

Objectives

- 1. Identify parent trees with high levels of rust resistance for seed collections,
- Assess nursery and field growth traits to determine suitability of genotypes to silviculture.
- 3. Quantify provenance level variation in order to derive seed transfer implications.

Discussion is needed on how this project supports FGC strategic objectives and on whether this work should be solely supported by FGC-directed LBIS funds or partnered with other funding groups.

Whitebark pine is a provincially blue-listed species and has recently been declared endangered under the federal *Species at Risk Act*.
